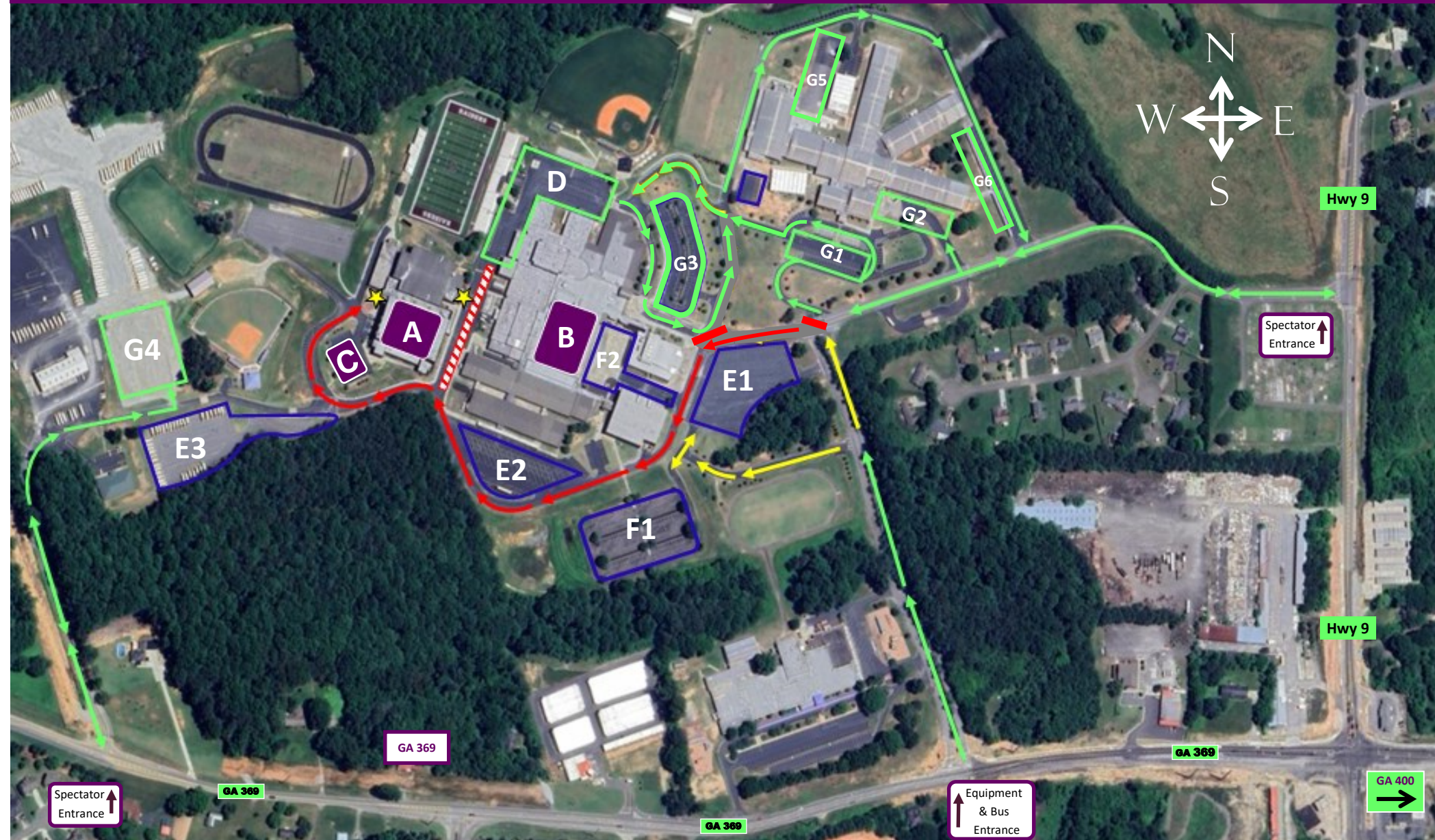

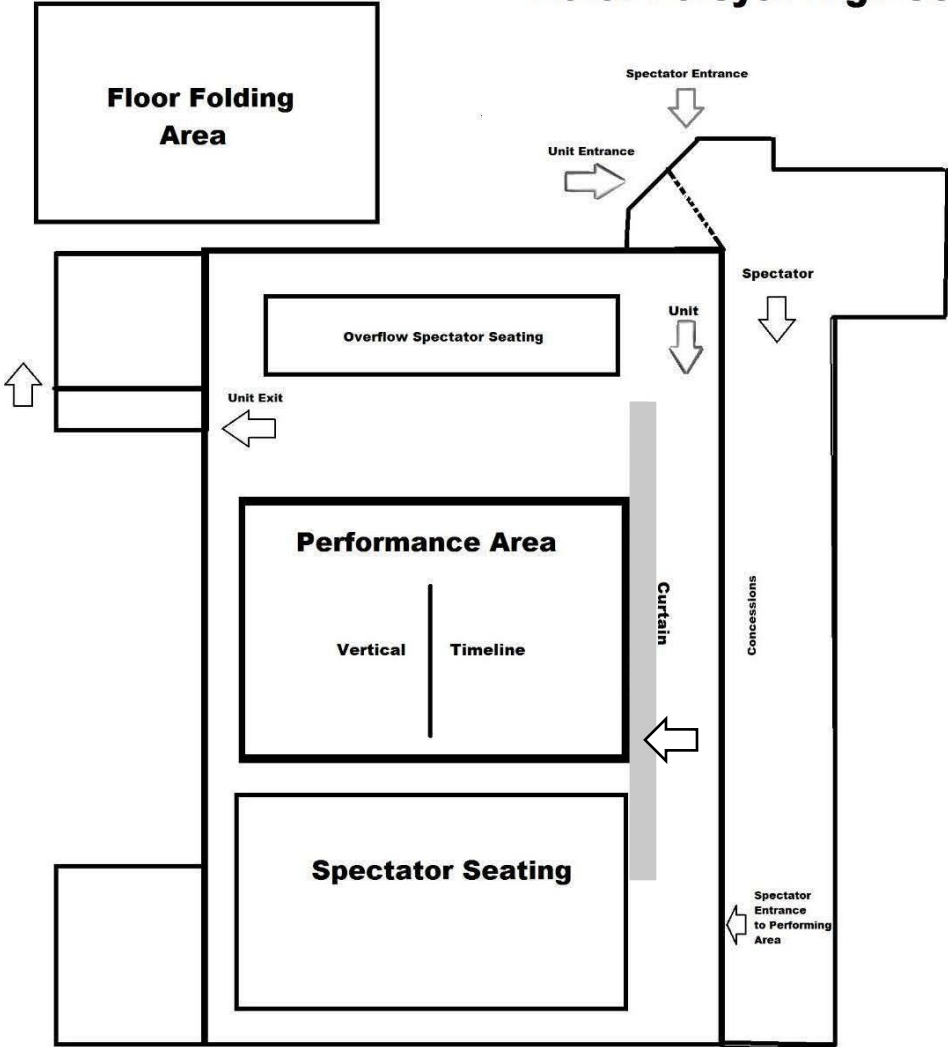

Directions to North Forsyth High School for the WGI Regional 3/16-3/17.

**Equipment Trailers, Trucks, and Busses:** ALL Equipment trailers and busses will enter NFHS off Highway 369 onto Coal Mountain Drive and proceed to the equipment/truck check in. Please note individual staff/parent cars will NOT be permitted to park with equipment trucks and will need to use the spectator entrance.

**Spectators, Staff, and Volunteers:** All Spectator, Staff, and WGI Volunteers will enter the campus through the entrance off of Highway 9 or the service road entrance off Highway 369 PAST the main entrance to the school. This entrance will be clearly marked. We will also have handicap accessible parking available.

## Atlanta Regional Competition Area North Forsyth High School | Cumming GA

All WGI contest sites must have a minimum of seventy feet by one hundred feet (70' x 100') to accommodate a "safety zone" of five (5) feet from any spectator seating. This will ensure the minimum sixty-foot by ninety-foot (60' x 90') competition area within the minimum seventy feet by one hundred feet (70' x 100') of the contest site. If no spectators are seated on the left and right sides, then the safety zone will be eliminated on the left and right sides of the competition area and extend to the walls.

The competition area at this event measures 72' x 106'. All performing groups must be prepared to perform within that area. Floors (tarps) may not extend into the safety zones per rules found in the WGI Adjudication Manual and Rulebook.
